Change of Branch in III SEM B.Tech Session 2019-20

As per the notification of Bikaner Technical University Bikaner (BTU), application for the change of branch is invited from the students of II Semester B.Tech session 2018-19

ELIGIBILITY CRITERIA

1. The students must have completed all the course credits of B.Tech I semester Examination in all Components (I.e Internal and external) in one attempt with at least 5.50 SGPA in the aggregate.
2. The student with back papers or whose result has not been declared due to any reason will not be considered for change of branch.
3. The following students will not be eligible for change of branch:-
 - a) Admitted under physically challenged category
 - b) Admitted under Ex-Serviceman, PIO/NRI
 - c) Admitted under Kashmiri Migrant category
4. In case any student has applied for re-valuation her marks of I Semester B.Tech. and the result has not been received till the time of change of branch; such a student will not be entitled for change of branch on the basis of her subsequently revised result. (received after the change of branch has been affected.)
5. No branch change is permitted against vacant TFWS Seat. However a TFWS students may seek branch change on non TFWS seats. Surrendering tuition fee waiver seat.


PROCEDURE

1. Student may collect application form from proctor section.
2. The student should submit a self attested photocopy of I semester examination mark sheet of the year along with the application form.
3. Those applicants belong to any category (SC/ST/OBC-Non Creamy/SBC-Non Creamy), should submit self attested photo copy of caste certificate.
4. Physical presence of candidate is essential Further in case, if any student does not present herself for counseling then her branch will be changed as per the candidate's preference given in the application form and according to merit. (as per guidelines provided by BTU Bikaner.)
5. Students applying for branch change have to come with their ID card at the time of submission of application form & at the time of counseling.
6. After branch change students are required to deposit a fees of Rs. 500/- in Account Section on the same day.

Last date of receipt of application form is 28/05/2019 up to 11.00 AM


Branch change process shall be held on 28/05/2019 at 01.00 PM in Proctor Section. All the concern students must be report in Proctor Section at 12.45.PM
