All the interested students need to apply offline in the attached format. The steps for applying are as follows:

Step 1: Download the blank Revaluation and Copy view form attached with this circular. Fill all the entries correctly and also attach copy of the marksheet. Students can apply for Revaluation and Copy view simultaneously. While Revaluation can be applied for maximum 4 subjects, Copy view can be applied for all the subjects.

Step 2: Deposit fee on the **SBI Collect** portal (Online). The revaluation fee is Rs. 600 per subject and Copy view fee is Rs. 1000 per subject.

Step 3: Submit hard copy of the duly filled Revaluation and/or Copy view form along with self-attested marksheet and original fee receipt in the Examination section between 10 a.m. to 3 p.m. on all working days.

The last date for applying offline is 30.04.2022 After that no form shall be accepted.

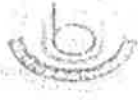
