- The robotic arm should be interfacable with MATLAB software in both programming and Simulink.
- One can be able to dump the MATLAB simulink model or code in its provided interface.
- The whole assembly should work in close loop environment, means once the MATLAB code/simulink model dump in robotic arm interface the robotic arm should move according to given input signal which should be traceable back on DSO and on MATLAB scope also
- Robotic arm should be capable of doing pick and drop operation

 Government Women Engineering College Ajmer has received a research grant from the All India Council of Technical Education (AICTE) New Delhi in collaboration with Technical **Education Quality Improvement Programme [TEQIP]-Phase III** Project under **Collaborative Research Scheme (CRS)** for TEQIP-III institutions in focus states and intends to apply part of the proceeds of this research grant under the CRS contract guidelines for which this invitation for quotations is issued.

### Quotation

- 3.1 The contract shall be for the full quantity as described above.
- 3.2 Corrections, if any, shall be made by crossing out, initialling, dating and re writing.
- 3.3 All duties and other levies payable by the supplier under the contract shall be included in the unit Price.
- 3.4 Applicable taxes shall be quoted separately for all items.
- 3.5 The prices quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- 3.6 The Prices should be quoted in Indian Rupees only.
- 4. Each bidder shall submit only one quotation and the bid/offer should be submitted in two bid systems (i.e.) Technical Bid and Financial Bid. The bidder shall submit the **Technical Bid and Financial Bids in separate sealed covers**, clearly super-scribing "**Technical bid for Robotic Manipulator**" and "**Financial bid for providing Robotic Manipulator**", respectively.
