Subject: Intimation regarding candidates selected for engagement as Assistant Professors (Temporary) under project TEQIP-III.

Dear Sir/Madam,

In response to your requisition sought for Assistant Professors (on contract) under project TEQIP-III, I am pleased to inform you that NPIU has completed the centralized selection process and selected candidates have accepted the offer online to provide their services at your institute.

(2) A discipline-wise list of such candidates accepted the offer in first round of allotment, is attached as **Annex 1** along with their details. These candidates are already communicated separately by NPIU requesting to report and join your institute during **28th December 2017, 10:00 AM to 5th January 2018, 01:00 PM.**

(3) For the purpose of joining, candidates shall bring the following documents along with them.

- Original documents of all educational qualification (score-sheets and certificates for 10th std, 12th std, bachelors, masters, PhD, GATE, NET/SET), experience certificates, proof for date of birth, PAN card, Aadhar card, bank account details, 2 passport size color photographs.
- Two sets of self-attested photocopies of all documents as indicated at 3(a) above (of which one set shall be submitted by the institute to NPIU within one week of his/her joining).
- A notarized affidavit printed on a stamp paper of INR 100/- (format attached here as **Annex 2**)
- A notarized undertaking printed on a stamp paper of INR 100/- (format attached here as **Annex 3**)
- Relieving certificate from the current employer.
- The institute should ensure that notarized document in 3(c & d) above, match word to word with the ones which are sent herewith. The officer conducting verification should be informed to check it carefully and accept the documents only when in order.

(4) Upon reporting by the candidates at your institute, their original documents shall be verified by the institute and if found in-order and satisfactory, they would be allowed for engagement at the institute. And, an engagement letter (format in **Annex 4**) duly signed by the Director/Principal of the institute will be issued to the candidates marking a copy to Central Project Advisor, NPIU. In response, candidates shall submit a duty joining report, a copy of which will be forwarded to CPA NPIU, also.

(5) In situations, please note that:

- Candidate unable to produce his/her original GATE score card since it was deposited at other institution for admission purpose, a photocopy duly attested (verifying the rank and score) by the concerned officer of that institute (mentioning the original document is deposited with the institute) might be acceptable.

- In the event an original document is lost, then an affidavit from 1st class magistrate / FIR copy must be produced by the candidate.
 - In case an original document is not available, an undertaking should be furnished by the candidate assuring that the needful shall be produced within 2 weeks from the date of joining.
 - If any information furnished by the candidate is found inconsistent or incorrect during verification or in future, an appropriate action shall be initiated against the candidate including rejection for joining the institute or termination of the engagement.
 - If the candidate fails to join within the stipulated time period, his/her candidature may be eliminated.
- (6) The candidates allotted for engagement need to be allowed to join immediately without delay (the institute may extend the office timings, if so needed).
- (7) In situation, a litigation by the existing faculty (guest/empaneled/contract) is currently subjudice, relevant order/interim order passed by the Hon Court, if any, should be honored & followed by the institute. Under the circumstance, the candidates engaged under project TEQIP-III might be assigned additional academic activities envisaged under the project as the part of their duty with due intimation to NPIU.
