NAME OF WORK : Partition and other work at (Temporary in Mech. Workshop) Mahi Hostel

1. The Performance security deposit amount shall be refunded only after the expiries of "Defects Liability Period" (1 year) i.e. after completion of work with satisfy report by the committee/ college authority.
2. All building material/ fixtures required for the construction work/Partition work, must be got tested and contractor has to submit the certificate for the same if required & got approved from the Mahila Engineering College authority prior to use. Any material not conforming to the specifications collected at site and defective work shall have to be removed by the contractor within a period of 24 hours of the instructions issued by the Mahila Engineering College authority. Failing which such material shall be removed by the college authority at risk and cost of the contractor after expiry of 24 hours period.
3. If prorata progress is not achieved then a part of work may be withdrawn from the contractor with a single notice of 3 days to get it executed from the other party & action shall be taken as per clause of agreement.
4. After completion of work, contractor has to clear the site as per direction of Mahila Engineering College authority within 3 days. Otherwise same shall be done by department at contractor's cost without issuing any notice.
5. Construction/work program shall be started by the contractor within 3 days of issue of work order and get approved from the Mahila Engineering College authority.
6. Quantities of any item may be increased or decreased or deleted as per site condition and as per instruction of principal of Mahila Engineering College. Nothing can be claimed extra for such charges in the item and also in the variation of quantities. All the instruction/ specification issued by the Mahila Engineering College authority from the time to time regarding construction addition or alteration shall be binding for the contractor.
